Penance Index

Eventual misdoings will be charged to the trader by the host, the association africa freedom, and debited (in as much possible) from the deposit.

The deposit will be transfered in CHF by june the 30th 2009 latest. In case the host may not have received your payment slip or account nr. as of this date, the deposit will not be payed back anymore.

In case of revocation with receipt of payment after march the 30th 2009: the entire amount is retained by the host or the partial amount still open is fall due.

In case of revocation of registration without billed amount received: the entire amount is fall due.

This works the same way for any further reservations such as tents, benches, fire extinguishers etc.

The renting of a parkingplace is mandatory and costs you 120 CHF for the entire time of the festival.

In case the host might have to speak out four warnings on the same issue, the host has the right to make the trader leave the clearance of event. All claims of the trader will extiguish at this point.
